

Return to Studio COVID 19 Waiver-Release **Read Carefully**

As Springfield Ballet returns to in-studio classes, rehearsals, and programs, staff, faculty, parents, and students will be required to comply with the safety requirements listed below. The undersigned authorize student's participation in classes or programs offered by Springfield Ballet, Inc. and agree to comply with the following conditions in exchange for participation in in-studio activities:

- Individual's temperature will not be taken prior to entry into The Creamery. Parents and students are asked to monitor student temperatures and refrain from attending in-person class or rehearsals if the temperature is elevated.
- All persons entering The Creamery, including students, will be required to wear facial masks. Inside The Creamery, facial masks must be worn in all shared spaces within the building including, but not limited to, offices, restrooms, Exhibition Hall, hallways, etc.
- Facial masks are required in the dance studio by both students and instructors. Springfield Ballet will provide disposable facial masks to staff, faculty and students if needed. If your student has a medical condition that in doing so would be contrary to his or her health or safety, please contact the Artistic Director.
- If a parent or student needs to speak with a staff member, an appointment needs to be scheduled in advance. No person may enter the offices without first scheduling an appointment.
- The locker and dressing rooms will not be available for student use. Students will be allowed to bring into the studio the following:
 - A bag no larger than 12" x 12"
 - Water bottle
 - A sealed bag (such as a Ziploc bag) to keep extra/soiled facial masks inside the student's larger bag.
- All persons must enter and exit The Creamery only through the east door into the Exhibition Hall.
- Parents/guardians are not allowed to enter The Creamery unless permission is granted by Springfield Ballet.
 - At the east-side entrance into The Creamery, Springfield Ballet will have a designated door monitor. Students will need to check-in / check-out with the door monitor, who will also maintain capacity within the shared spaces, ensure visitors maintain social distancing and disinfect the waiting areas used once visitors leave the building.
 - Students will be allowed to enter The Creamery five minutes before their class begins.
 - Dancers and parents waiting outside The Creamery by the east-side door must maintain social distancing and mask requirements as best they can.
 - Students in levels Dance With Me, Creative Movement 1, Creative Movement 2 and Pre-Ballet may have one parent/guardian with them inside The Creamery during class/rehearsal. Waiting areas for parents/guardians are the Exhibition Hall and Arts Library, and will be designated with x's on the floor. During First Friday Artwalk, the waiting area will be the Board Room.
- Students between ages 8 and 12 are asked to have one parent/guardian drop-off and pick-up at the east-side entrance to The Creamery for student safety.

- All parents and students must make a FULL commitment to respecting and adhering to social distancing and mask requirements within the building at all times, including in shared spaces, studios, restrooms, the kitchen, etc.
 - Congregation of persons shall be limited as much as possible.
 - All persons must maintain six-foot distancing from others at all times.

Springfield Ballet faculty, staff and door monitor will remind and monitor students and parents of these requirements while visiting The Creamery.

We have read the above requirements and agree to adhere to them. If either the student or parent does not follow this agreement, they will receive written notice from Springfield Ballet staff that they are not allowed back into The Creamery until further notice.

The undersigned recognize and acknowledge that the activities and classes with Springfield Ballet, Inc. are voluntary. Parent and student must decide whether student should participate in classes or activities offered by Springfield Ballet, Inc. These requirements are provided to minimize health risks based on information known at this time, but are not a guarantee that all health risks can be eliminated. We acknowledge that participation in classes and activities with Springfield Ballet, Inc. creates certain risks of exposure to illness. Parent and student hereby release, waive, relinquish, and discharge Springfield Ballet, Inc., and any and all employees, directors, officers, insurers, agents, and/or volunteers from any and all claims demands, action, or causes of action whatsoever, arising out of or related to any loss, damage, injury, or illness that may be sustained by student's participation in classes and activities, whether caused by negligence or otherwise. Parent and student further acknowledge that they understand that this is a full release. This release is separate and additional to any other liability release previously executed by parent and/or student. Parent and student voluntarily waive their individual rights and those of their insurer.
